Corporate Restructuring

Corporate Restructuring through a Scheme of Amalgamation under Section 284 of the Companies Act, 2017 (the "Restructuring") involving SLG and its wholly owned subsidiaries, namely (1) SecurLog (Pvt.) Ltd. ("SLL"), and SecureTrack (Pvt.) Ltd. (STL), achieved closure effective September 19, 2017. Consequent to the above closure, the logistic and vehicle fleet management businesses, hitherto part of SLL and STL have become two independent business segments of SLG





Capital Raising

- Round 1 capital raising through Pakistan's first quasi-equity issue by a logistics company
- PKR 600 Million through Convertible TFC issue in January 2019.
- Investors include Pakistan Catalyst Fund (PCF) and JS Bank Limited (JSBank)
- Funds utilized for major fleet expansion by way of an addition of 54 Prime Movers & Semi-Trailers each





Capital Raising (Cont'd)

- Round 2 capital raising by way of private placement of equity
- PKR 1.20 billion through an equity issue in January 2020
- Investors include Karandaaz Pakistan (KP) and Saudi Bugshan Group (SBG)
- Funds utilized for further scaling up of business through an addition of 35 Prime Movers / Semi-Trailers, 70 Distribution Vehicles, 80 containers of 40 Feet, 158 external fuel tanks on each Prime Mover, etc.






SLG at a Glance - 2020

Transportation Industry Dynamics

- The domestic transportation industry is driven by the underlying dynamics of various modes of transport Cargo transported by road (which carries 96% of all domestic freight movement) has seen consistent increases over the past fifteen years whereas freight by railway and declined steeply
- Number of registered cargo trucks increased from less than 150k in 2000 to over 270k in 2017
- Number of operational railway freight wagons decreased from 24k in 2000 to 16k in 2017



Share of commercial cargo and passengers transported by road rail, air etc.




Transportation Industry Composition & Positioning

- The domestic transportation is large and unorganized, comprising mostly of small, owner-driven fleets of less than five vehicles. Few players only with larger fleets and sufficient financial backing
- The overall trucking fleet is comprised of older technologies with average lifespan of 6-8 years. Therefore, there is significant demand for Prime Movers and multi-axle trucks and trailers






